ATMAE Bylaws, Article II - Executive Board Members & Terms of Office 2010-2013 Elections

2.1 Composition: The Executive Board shall consist of a Chair, two representatives of the Two-Year Program Faculty membership class, two representatives of the Four-Year Program Faculty membership class, one representative of the Industry membership class, one representative from the National Industry Advisory Committee (NIAC), and one representative of the Student membership class.

2.3 Term of Office: The term of office of all members of the Executive Board except the Student Representative is three years; the term of office of the Student Representative is one year.

2.3.1: Staggering of Terms of Office and Impact on Initial Terms of Office: The initial terms of office for the following positions on the Executive Board shall be as follows:

2.3.1.1 Industry Representative: Initial term of two years.

2.3.1.2 Two-Year Program Faculty Representatives: Initial term of one year for one representative and two years for the other representative.

2.3.1.3 Four-Year Program Faculty Representatives: Initial term of one year for one representative and two years for the other representative.
